Compensation Changes

As announced in October, the APEHP broker compensation structure is changed for all business effective January 1, 2019. The changes are applicable for all new, renewal and existing business as follows:



Schedule A - Amended Commission Schedule Effective 1/1/2019

Enrolled Employees Per Group	2019 Commission	2018 Commission
1 and 2 Enrolled Employees	2.5%	5%
3 to 24 Enrolled Employees	4.5%	5%
25+ Enrolled Employees	5%	5%

Commission % may change month to month, based on number of enrolled employees. Commissions are only paid when an invoice is paid in full.

Jet Insure Update

Introducing SmartyStreet

You may have noticed when entering a new member or updating an address in Jet Insure that you are now able to verify the address data that you are entering. This "double check" will alert you if there is a city/state/zip mismatch or if an apartment # is missing. It is still important to remind your clients to communicate member and group address changes to the Plan timely since the system will not pick up if the member has moved or if a forwarding address has expired.

Re-Credentialing

APEHP is excited to announce upcoming enhancements to our "Quote to Card" Jet System. The enhancements will include a new broker portal that will provide important information related to your employer groups. The broker portal allows you and your teams to effectively manage your book of business enrolled in APEHP. You will soon have access to your groups information, paid healthcare fees, paid commissions, notifications and reporting.

Brokers that work with any of APEHP General Agencies will also have access to their accounts where they are listed as sub-producers. This change will allow sub-producers to have greater access to view/manage their active accounts with the Plan.

The first order of business in the process is the **Re-credentialing** of all General Agents and Brokers. Your agency point of contact will receive an email with a web link to complete their re-credentialing. The links will be sent out during 1st Quarter 2019. We will keep you posted so you can keep an eye out for the link.
